



## **INVITATION FOR BIDS**

The City Of Alamosa, will be accepting bids to construct a new sanitary lift station until January 22, 2021 at 1:00 p.m., Mountain Standard Time. Please send or deliver sealed bids to the Public Works Department, located at 300 Hunt Avenue, Alamosa, CO 81101. Immediately following the deadline, all qualified bids will be publicly opened and bid prices read aloud for furnishing labor, equipment, and materials needed to replace the existing lift station.

This project, entitled "Alamosa Lift Station Replacement" is briefly described as follows:

The work includes installing a new lift station, valve vault, pumps and controls (owner supplied), generator, fencing, and force main tie-in to city infrastructure. See plans for full details.

All bids must be submitted, and all work done in full compliance with:

- The plans and specifications for the project
- Any special provisions for this project
- The 2012 City of Alamosa Standard Construction Specifications, as amended

There will be a mandatory site visit January 14, 2021 at 1:30 PM. Location of site is on the northeast corner of First St. and Alamosa Ave.

Bids may also be hand-delivered to the Public Works Department, 300 Hunt Avenue. The bid must be placed in one envelope with the name of bidder and bidder's address, securely sealed, and clearly labeled: "Alamosa Lift Station Replacement"

The City of Alamosa shall not be responsible for premature opening of bids not properly labeled. All bids are to be submitted on the basis of cash payment for the work and materials and shall be accompanied by a certified check or bidder's bond in an amount not less than five percent of the total bid amount. The check(s) or bond(s) shall be made payable to the City Clerk, Alamosa, Colorado, as security that the bidder(s) to whom the awards(s) are made will enter into contract to build the improvements bid upon and furnish the required bonds and insurance.

Only those bids received by the Public Works Department on or before January 22, 2021 @ 1:00 p.m., Mountain Standard Time will be eligible for consideration. Any bid received after the closing time, regardless of the method of delivery, shall be returned unopened to bidder.

The successful bidder will be required to begin the work outlined herein and depicted on the project plans no sooner than 30 days from receipt of a Notice to Proceed, and to complete the work prior to June 30, 2021.

The low bidder shall supply the names and addresses of major material suppliers and subcontractors when required to do so by the Owner.

All work is to be guaranteed for a period of one year following final acceptance. No bid may be withdrawn within a period of sixty (60) days after the date fixed for bid opening.

The City Of Alamosa reserves the right to reject any and all bids and to waive informalities in bids submitted and to accept whichever bid that is in the best interest of the City, at its sole discretion.
