



INVITATION FOR BIDS-Rebid

The City Of Alamosa, is accepting bids to recondition (CIPP lining) 570 LF of 16" Sanitary sewer pipe. Bid will be accepted until **March 24, 2023**, at 1:30 pm Mountain Standard Time. Please send or deliver sealed bids to the Public Works Department, located at 300 Hunt Avenue, Alamosa, CO 81101. Immediately following the deadline, all qualified bids will be publicly opened and bid prices read aloud for furnishing labor, equipment, and materials needed to Recondition/Reline the existing sewer lines..

This project, entitled "**2023 CIPP Reconstruction of Pike Ave and Seventh St. Sewer Lines**". is briefly described as follows:

The work includes Cleaning and CCTV 532 ft of sewer lines and the installation of Cured-In-Place Pipe (CIPP). As a mandatory bid option, Bypass pumping will be included as a separate line item if needed. Refer to the included map for the location of Sewer Lines..

All bids must be submitted, and all work done in full compliance with:

- The identified scope of work
- Any special provisions for this project
- The 2022 City of Alamosa Standard Construction Specifications

Bids may also be hand-delivered to the Public Works Department, 300 Hunt Avenue. The bid must be placed in one envelope with the name of bidder and bidder's address,

securely sealed, and clearly labeled: **“2023 CIPP Reconstruction of Pike and West 7th Sewer Lines”**

The City of Alamosa shall not be responsible for premature opening of bids not properly labeled.

Only those bids received by the Public Works Department on or before **March 24, 2023**, at 1:30 pm, Mountain Standard Time will be eligible for consideration. Any bid received after the closing time, regardless of the method of delivery, shall be returned unopened to the bidder.

The successful bidder will be required to begin the work outlined herein and depicted on the project plans no sooner than 30 days from receipt of a Notice to Proceed, and to complete the work prior to **July 31, 2023**.

The low bidder shall supply the names and addresses of major material suppliers and subcontractors when required to do so by the Owner.

All work is to be guaranteed for a period of one year following final acceptance. No bid may be withdrawn within a period of sixty (60) days after the date fixed for bid opening.

The City Of Alamosa reserves the right to reject any and all bids and to waive informalities in bids submitted and to accept whichever bid that is in the best interest of the City, at its sole discretion.

The price state in this proposal includes:

1. One mobilization and demobilization. Based on mutually agreeable between contractor and the Public Works Representative. there must be at least one-week advance notice of any changes to the mutually agreed upon schedule.
2. Installation of Cured-In-Place Pipe (CIPP) lining per ASTM F1216 Cured-In-Place Lining including inversion, curing, and finishing.
3. Pre-Video inspection, documentation and verification of size of existing pipe prior to reconstruction with the process for pipe rehabilitated by CIPP.
4. Pipeline cleaning. loose debris and all deposits.
5. Internal lateral reinstatement.
6. Post Video inspection following completion of the installation to document new pipe rehabilitated by CIPP.
7. Traffic Control
8. Confined Space entry Practices
9. Bypass for installation if needed.
10. Certificate of insurance with a standard coverage

We believe them to be Asbestos Cement/ Concrete
3. Do you require bypass pumping for CIPP only or also for CCTV clean & video?
Due to the challenges of working with a busy State Hwy, no bypass pumping. We expect the work to be completed at night. The City will plug and hold material for up to 4 hours.
4. Standard CCTV cleaning is three passes with a high velocity jetter and for areas that require heavy cleaning, additional calcium grinding may be required. Do you anticipate heavy cleaning to be needed for this project, and if so, how much heavy cleaning, and how would it be compensated?
